

December 1, 2014
Regular Session

The meeting was called to order by Mayor Glenn Wright. Members present were Mr. McWhorter, Mrs. Wynn, Mr. Rhodes, and Mr. Miller.

Mrs. Wynn opened the meeting with prayer.

Mr. Miller made a motion to approve the November 17, 2014 regular session minutes as presented, after a second by Mr. McWhorter the motion passed 4-0.

Mrs. Wynn made a motion to approve the November 17, 2014 call meeting minutes as presented, after a second by Mr. McWhorter the motion passed 3-0-1 with Mr. Miller abstaining.

Mr. McWhorter made a motion to approve the November 17, 2014 executive session as presented, after a second by Mr. Miller the motion passed 4-0.

Ms. Pam Askew, Director of Festival Hall, presented a budget report and discussed some of the different events scheduled for the upcoming year.

Mr. Brian Casey was presented with a certificate of appreciation for having served on the Planning and Zoning Board for the past 8 years.

Mr. McWhorter made a motion to approve a resolution to extend its moratorium on granting business licenses and zoning requests to personal care homes and community living arrangements until December 16, 2014. After a second by Mr. Miller the motion passed 4-0.

A first reading of the ordinance amending Article IX Special Provisions of the Zoning Ordinance was done.

Mr. Rhodes made a motion to close City Hall at 12:00 pm on Wednesday, December 24th through Monday, December 28th, after a second by Mrs. Wynn the motion passed 4-0.

Mr. Miller made a motion to close city hall on Thursday, January 1, 2015 for New Year's Day, after a second by Mr. McWhorter the motion passed 4-0.

Mr. Rhodes made a motion to accept the recommendation of the City Manager to have an employee luncheon on Wednesday, December 24th for all employees, after a second by Mr. McWhorter the motion passed 4-0.

City Manager Postell made a recommendation that all firemen of the Greensboro Fire Department be given an incentive based on drill attendance. Mr. Miller made a motion to accept the recommendation of City Manager Postell, after a second by Mr. Rhodes the motion passed 4-0.

City Manager Postell recommended an incentive be given to all employees in the amount of one week's pay. Mr. Miller made a motion to accept the recommendation from the City Manager, after a second by Mrs. Wynn the motion passed 4-0.

Mr. McWhorter made a motion to enter into executive session to discuss three pending legal matters, after a second by Mr. Rhodes the motion passed 4-0.

No action was taken in executive session. Mrs. Wynn made a motion authorizing Mayor Wright to sign an affidavit regarding executive session, after a second by Mr. McWhorter the motion passed 4-0.

Mr. Rhodes made a motion to adjourn the meeting, after a second by Mr. McWhorter the motion passed 4-0.

There being no further business Mr. McWhorter closed the meeting with prayer.
