Regular Session

The Greensboro City Council Regular Session was called to order by Mayor Glenn Wright. Council Members present were Mr. McWhorter, Mr. Smith, Ms. Rivers, Mr. Moore, and Mr. Miller.

Ms. Rivers opened the meeting with prayer.

Mr. Miller made the motion to approve the July 19, 2021 Regular Session Minutes as presented after a second by Mr. McWhorter the motion was approved 5-0.

Elizabeth Elliot, the Preservation Planner of the Office of Downtown Development with the Georgia Department of Community Affairs was present to speak about the Greensboro Main Street Program and gifted a new gateway sign to the Greensboro Main Street Program and congratulated the City of Greensboro on being redesignated as a Georgia Exceptional Main Street.

Ms. Gunter made a request on behalf of the Greene County High School to close Highway 44 and City streets to have the Homecoming Parade on Thursday, September 2, 2021 beginning at 4:30pm. Mr. Miller made the motion to approve the request, after a second by Mr. McWhorter the motion was approved 5-0.

City Manager proposed to have a firing range constructed at the old inert landfill on Penfield Road. In house labor will be used to clear the land. The property is owned by the city and will be available for use by other police departments. Officers will use the facility to do yearly qualification. Classes for the public will also be offered. Mr. Smith made the motion to approve the request from the City Manager, after a second by Mr. Miller the motion was approved 5-0.

#### Unfinished Business

Mr. Smith made the motion to dedicate the newly erected basketball court in honor of Mr. Felton Hudson, after a second by Mr. McWhorter the motion passed 5-0.

Mr. Miller made the motion to accept the recommendation from the Planning and Zoning Board and annex tax parcel 086-0-00-048-0 and 086-0-00-046-0 into the city limits the property is owned by Circle Ranch, Inc and located on Old Union Point Road, after a second by Mr. Smith the motion was approved 5-0.

Mr. Miller made the motion to rezone tax parcel 086-0-00-048-0 and 086-0-00-046-0 from A-1 Agricultural District to CPUD Commercial Planned Unit Development the property is owned by Circle Ranch, Inc. and located on Old Union Point Road, after a second by Mr. Smith the motion was approved 5-0.

#### New Business-

Mr. Miller made the motion to approve a Special Events Beer and Wine Permit for Festival Hall Inc for an event on September 10, 2021, after a second by Mr. McWhorter the motion passed 5-0.

Mr. Smith made the motion to enter Executive Session, after a second by Mr. Miller the motion was approved 5-0.

No action was taken in Executive Session 4 Personnel Matter were discussed. Mr. McWhorter made the motion authorizing Mayor Wright to sign an affidavit regarding Executive Session, after a second by Mr. Smith the motion was approved 5-0.
