The Greensboro City Council Regular Session Meeting was called to order by Mayor Corey Williams. Members present were Mr. Neal, Mr. Moore, Mrs. Rivers, and Mr. Miller.

Mayor Williams opened the meeting with a prayer.

Mrs. Rivers made the motion to approve the July 18, 2022 regular session minutes as presented, after a second by Mr. Neal the motion was approved 4-0.

Mr. Miller made the motion to approve the July 18, 2022 regular session minutes as presented, after a second by Mr. Moore the motion was approved 4-0.

Mr. Moore made the motion to accept the recommendation coming from the Planning and Zoning Board and approve the request from Donna Chester for a variance to add a kitchen addition from the property located at 609 South Main Street tax parcel G070000490, after a second by Mr. Neal the motion was approved 4-0.

Mr. Miller made the motion to accept the recommendation coming from the Planning and Zoning Board and approve the request from Himanshu Bhatwala for a variance for a change in parking space dimension for the proposed Holiday Inn Express located on Lake Oconee parkway tax parcel 052000024C.

Mr. Neal made the motion table the request from Tony Brewer of Forr Properties to annex 42 acres into the city limits of Greensboro tax parcel 0520000170 located on Lake Oconee Parkway/Hwy 44, after a second by Mrs. Rivers the motion was approved 4-0.
